 - c. All vehicles used by registered members during and around any club sponsored and non-sponsored events must hold valid up to date insurance certificate. Insurance certificate must be shown at time of registration or entrance to events.

Any Driver Member or Child non Driver Member found to be under the influence of any mind altering substance: drugs, alcohol, or for Driver Members who are driving with prescription drugs that have been label to avoid operating vehicles and machinery will receive a life-time ban from the club. No exceptions!
 - e. Any member receiving any traffic citation during any club sponsored or non-sponsored event in which the club is participating as a group will receive an automatic 90 day suspension from any future club sponsored event or non-sponsored event in which the club is participating as a group.
